Demographics


Masten has a larger proportion of youth and seniors than most other council districts, with a smaller proportion of residents age 18-64. At 11.3%, Masten has the highest unemployment rate of the districts. It also has the second smallest population of residents born outside of the United States: just 4% of the

district. Most district residents identify as black (82%), while roughly one in ten identifies as white.⁶ The district's Hispanic community is quite small, at 3.2% of the population.⁷




Poverty and Unaffordable Housing

Over a third of the district's residents have an income below the poverty line. Most renter households in the district (60%) cannot afford their housing costs, (meaning that housing costs exceed 30% of the household's income). The same is true for about one in every four owner-occupied households. Over 5,000 Masten households (renters *and* owners) live in unaffordable housing, 45% of all Masten district households.

Education¹³

85% of Masten residents age 25 or older are high school graduates. Most od the district's residents (55%) have pusued higher education.


EDUCATIONAL ATTAINMENT FOR MASTEN DISTRICT RESIDENTS AGE 25 OR OLDER, 2014-2018
